#### **Project Update**

#### **Design Parameters**

- Design meets MassDOT and Federal Highway Standards
- Design meets Massachusetts Architectural Access Board (AAB) and Americans with Disabilities Act (ADA)
   Requirements
- Proposed 12-foot-wide path constructed with hot mix asphalt (HMA)
- Proposed 4-foot-wide soft surface shoulder for walking/jogging on one side of path
- Drainage swale proposed along north side of path to intercept stormwater from path
- Underpass beneath railroad tracks at Alexander Avenue to connect Middle/High Schools to Channing Road
- Retaining walls to support path at some locations
- Landscaping along path for comfort and screening
- Path access points at Pleasant Street, Concord Ave at Belmont Center (Belmont Station), 7 Channing Road (Chase Bank), Alexander Avenue Underpass, Brighton Street
- New traffic signal at Brighton Street / Railroad Crossing
- Proposed lighting (Alexander Avenue Underpass Only)

#### What We Heard From the Community

#### ...and how we integrated your comments into the 25% design:


- Modify the "Clark Street Spur" and path alignment shown on the July 2020 DRAFT plans
  - The proposed path alignment has been revised to include a single path connecting to Pleasant Street and the Clark Street pedestrian bridge
- Provide several access points to the Community Path
  - Pleasant Street and Clark Street Pedestrian Bridge
  - Concord Avenue/Belmont Center at Belmont Station
  - Proposed path connection at 7 Channing Road (Chase Bank)
  - Alexander Ave Underpass / Channing Road
  - Brighton Street and Fitchburg Cut-off Trail
- Brighton Street Traffic Signal
  - Allow for path users to cross Brighton Street while railroad gates are down

#### What We Heard From the Community


#### ...and how we integrated your comments into the 25% design:

- Drainage/flooding problems on Channing Road properties
  - Added drainage swale and sub-drain on north side of path to intercept runoff
- Minimize Tree Cutting / Preserve Existing Vegetation
  - Revised path alignment and profile to limit the removal of trees where possible
  - Provide screening to address privacy concerns
- Accommodate Maintenance and Emergency Vehicles
  - Design Path access points to allow for emergency vehicles
  - Proposed 8-foot chain link fence with gates for MBTA/Emergency Access
  - 14-foot-wide clear along north side of the tracks for MBTA access
  - Alexander Avenue underpass designed for emergency vehicle access



Plan: Clark Street / Pleasant Street Connection











### **Typical Path Section Along Channing Road**












**ALEXANDER AVENUE SPUR - UNDERPASS SECTION**







SECTION 10: ALEXANDER UNDERPASS AND COMMUNITY PATH JUNCTION SCALE: 1" = 10'-0"












**BELMONT COMMUNITY PATH - 40 BRIGHTON STREET ABUTTING PARKING** 


### **Brighton Street Crossing**

#### PREFERENTIAL PHASING SEQUENCE






Site Plan: 40/42 Brighton Street





#### 25% Design Summary

- 12-foot wide path with a 4-foot shoulder for walking/jogging and a 2-foot grassed shoulder
- Drainage swale and sub-drain along north side of path to intercept and collect stormwater runoff
- Underpass beneath railroad tracks at Alexander Avenue providing connection to Concord Avenue
  - Tunnel Jacking Method Required by MBTA
- Proposed lighting at Alexander Avenue underpass only
- Improved safety at Brighton Street crossing with new traffic signal
- Proposed landscaping and amenities along corridor
- Community Path Access Points:
  - Clark Street Bridge and Pleasant Street
  - Concord Avenue at Belmont Center
  - Chase Bank (7 Channing Road)
  - Channing Road via Alexander Avenue underpass at Middle/High School
  - Brighton Street
- 25% Estimated Construction Cost is about \$17 Million
